## Inclusion of New Clauses in page No. 3 in Paga No. 2, delete Clause A and C and inclusion of the below mentioned Clauses:

- a) To establish and/or takeover and/or manage educational institutions such as School, College, Technical Institute, Vocational Training centre, Medical College, Nursing School and/or College, Engineering College, Management Institute and/or any other type/nature of educational institution or institute so as to impart formal/informal value-based education, vocational training, crafts and technical skills to individuals or families in need, directly on its own or in cooperation with other voluntary and/or Government organizations, primarily for the benefit of Christians and also the same shall be extended to others irrespective of caste, creed, colour, sex etc.
