



Inclusion of New Clauses in page No. 3 in Para No. 2, delete Clause A and C and inclusion of the below mentioned Clauses:

- a) To establish and/or takeover and/or manage educational institutions such as School, College, Technical Institute, Vocational Training centre, Medical College, Nursing School and/or College, Engineering College, Management Institute and/or any other type/nature of educational institution or institute so as to impart formal/informal value-based education, vocational training, crafts and technical skills to individuals or families in need, directly on its own or in co-operation with other voluntary and/or Government organizations, primarily for the benefit of Christians and also the same shall be extended to others irrespective of caste, creed, colour, sex etc.
- c) To engage in activities of educational, social, cultural, moral or any other activity that contribute to the total development of the society at large, especially Christians and backward classes without any discrimination as to caste, creed, colour, sex etc.
